Welcome and chaired by Lynn Vanlieshout- Opening Statement: The FC Chair welcomed everyone to the Faith Manor Family Council Meeting. - 3. New Business (45 minutes)
  - Home Update Sellinor Ogwu-Administrator-(10-15min)-Home is at full capacity for approximately 3 weeks; suspect outbreak x1 resident with covid-staff did a great job at maintaining IPAC measures. What's been noticed is staff aren't getting the virus. No staff were reported unwell during this time frame. Sellinor spoke the the heat risk and the current temperatures are very hot so residents are to stay inside under heat risk assessment and policies/procedures to adhere to. Once heat risk lifts, residents will be brought out for fresh air. Some of our extra psw students will assist as well as the placement students in addition to recreation. Sellinor also shared about the extra psw coverage that FM will have and the ratio of staff to resident. A job fair was held and now the process begins of bumping and waiting for paperwork to be completed or hire which takes time. Comment: family member indicated there doesn't seem to be extra psw on the home areas. Sellinor said they are currently in the middle of all this and waiting on the police check does pose a delay. She also some staff have been part time for over 3 years and deserve to get a full-time line. She also indicated that if there were more full-time lines it might offer increases stability. Sellinor understood-shared the offer for staff to do the 12 hr shifts and 4 days.../week but it was declined and often times once a hire is initiated, time HCH gets to them during the process they have already left and found another job at the hospital etc. so competition is also a factor in the hiring process.
  - Mebratu Gebru-Spiritual Care Coordinator-Introduction/Mebratu was introduced to team. Hired and commenced April 10/24He spoke a little on himself and Jody chimed in with the new role and how we will continue to build on it-some will be trail and error and still a lot of learning to do! - Wishing well program-Jody (5 min)-Jody indicted there was 2 ballots indicating an increase n pet therapy and music therapy from same individual. Jody explained to group that we have music daily, have entertainment indie and out, music on the patio, scheduled entertainers, hymn sings, tv music, nature etc. as for pet therapy, we have 2 therapy dogs from St john's ambulance that come based on times good for the volunteer so may be hit and miss for family to see. They are loved by all the residents. We also offer various programs where we have hands on exotics, critter visits inside and out and we are adding bird visits for august name Delray! We have to be careful of fear, allergies of residents and staff. Jody will contact person and make a progress note. All member satisfied.
- RAPS Program/Env Update-(10 min) our inventory of achievement gets updates annually. Some changes and upgrade to the spa rooms at GM have been noted. They also purchased an owl to help keep the geese away we didn't do that on time for FM.
